



Human Trafficking Collaborative Network Endowment Scholarship Application

The **Human Trafficking Collaborative Network** (HTCN) **Endowment Scholarship** aims to provide funding support to survivors of human trafficking and higher education students interested in combatting human trafficking. This fund will, thus, support the educational activities of undergraduate, graduate (e.g. medicine, public health, and social work) and vocational school students in the St Louis region. Individuals with lived experience of human trafficking are highly encouraged to apply for this HTCN scholarship opportunity.

Eligibility Criteria

Must Be

- 18 or over and have lived experience of or be a survivor of human trafficking
- A graduate, undergraduate, or vocational school student with demonstrated interest in anti-trafficking in persons work.

Scholarship Package

• The award is \$1,000 each for 2 recipients to support educational activities.

Scholarship Expectations

- Award holders are each expected to submit a 1-2 page description of how the funds were used to advance the career/academic goals. This should be done 9 months to 1 year after receipt of the award.
- Proof of enrollment in school for the upcoming semester or receipt from one of the anti-trafficking-related education on-line courses will be required.

Scholarship Award Use

- For Survivors of Human Trafficking: Scholarship awards may be applied toward tuition or other fees directly related to vocational or higher education studies in ANY discipline or subject of study.
- For Applicants with a demonstrated interest in anti-human trafficking: Scholarship awards may be applied toward tuition or other fees directly related to courses or trainings associated with anti-human trafficking.
